MESSAGE FROM THE PRESIDENT

A wise person once said: "Always remember your roots. They are the foundation of your life and the wings of your future." NAHO's roots grew from the National Judicial College (NJC).

In the mid-eighties, the NJC jointly sponsored three consecutive conferences for administrative hearing officials. From these conferences, with the help of hearing officials across the nation, NAHO began in 1987. The first professional development conference held by the National Association of Hearing Officials was in 1988 at the National Judicial College in Reno.

Since 1961, the NJC has instructed newly appointed or elected adjudicators of all kinds in the finer points of judging and has provided continuing professional development. The NJC's idea on how best to do this, which was novel at the time—was judges teaching other judges.

In 1972, the NJC added courses for administrative hearing officials to its curriculum. Since that time, the NJC has provided instruction to thousands of administrative adjudicators of many different jurisdictions and levels of government. Including the custom courses that the NJC provides, administrative hearing officials make up approximately 33% of the NJC's annual enrollment. Because the NJC believes in "judges teaching judges," much of their faculty for hearing officials is comprised of experienced administrative adjudicators. If you attend this conference, you'll be meeting some of that faculty in a facility that was designed specifically for people like NAHO members.

Our host hotel, the Whitney Peak, is a non-gaming, non-smoking hotel that is very near the beautiful Truckee Riverwalk. The 3.5-mile Riverwalk winds its way through Reno, passing many taste-tempting restaurants, and interesting shops, pubs, and galleries. Within easy walking distance of the hotel, you'll find the National Automobile Museum and a variety of live entertainment. Also, nearby is the National Bowling stadium—known as the Taj Mahal of bowling—where you can bowl or visit the bowling museum. The Reno Aces will be playing the Salt Lake Bees at their new minor league baseball park which is an easy stroll around the corner and down the street a bit.

Reno is at an altitude of 4,500 feet in the heart of the picturesque Sierra Nevada Mountains. September is the ideal month to visit there. Daytime highs will be around 82 degrees and the overnight lows around 45. As Reno is in the "high desert," rain is highly unlikely, but bring a jacket or sweater for the cool Reno evenings.

MAKING HOTEL RESERVATIONS

Located at 255 N. Virginia Street in Reno, the Whitney Peak Hotel is offering NAHO conference attendees a <u>special</u> <u>discounted room rate of \$114.00 per night</u> based on the per diem set by the General Services Administration.

This rate is only available these nights: Saturday, September 9 through Thursday, September 14. Rooms will be available before and after these dates at the prevailing rate. These rates are subject to 8.27% sales tax and 13.5% lodging tax, which may change without notice based on state and local laws. Reservations must be guaranteed with a major credit card or accompanied by a first night room deposit. The hotel will not hold any reservations unless secured by one of these methods.

To receive NAHO's special discounted rate, reservations must be received by the hotel by Friday, August 16. After August 16, the hotel will release all remaining rooms for general sale at the prevailing rate. NAHO conference attendees can easily make room reservations at NAHO's special rate HERE.


NAHO's guaranteed room block for the conference is limited, so please make your reservations early!

SCHOLARSHIPS AVAILABLE FOR NAHO'S 2023 PROFESSIONAL DEVELOPMENT CONFERENCE

The NAHO Board of Directors has authorized a limited number of partial and full scholarships to NAHO members to attend the 2023 Professional Development Conference. Full scholarships cover the total cost of registration to attend the entire conference and all group meals that are a part of the conference. Partial scholarships cover a portion of the registration fee to attend the entire conference and all group meals that are a part of the conference. NAHO scholarships do not cover travel/transportation expenses, lodging expenses or meals that are not provided as a part of the conference. All scholarship applicants must be members in good standing of NAHO or must have applied to be members of NAHO at the time the scholarship application is submitted.

Each year, NAHO offers one or more additional scholarships to the NAHO conference to alumni of The National Judicial College in appreciation of NJC's enduring commitment to the education of administrative adjudicators and in acknowledgment of its longstanding partnership with NAHO. Full conference scholarship(s) for NIC alumni cover the total cost of registration to attend the entire conference and all group meals that are a part of the conference. Partial conference scholarships for NJC alumni cover a portion of the registration fee to attend the entire conference and all group meals that are a part of the conference. Scholarships for NJC alumni do not cover travel/transportation expenses, lodging expenses, or meals that are not provided as a part of the conference. All applicants for NJC alumni scholarships to attend the 2023 NAHO conference must be an alumnus of the National Judicial College in addition to being a member in good standing of NAHO or an applicant for membership in NAHO.

Those interested a scholarship must complete the scholarship application on the NAHO website or submit a letter to the NAHO Scholarship Committee with information indicating:

- You are a member in good standing of NAHO or have applied to become a NAHO member. Your status may be verified by providing the date you became a member or the date of your membership application.
- Your employer, job title, length of time you have been a hearing official.
- Whether you'll be receiving any financial assistance from your agency or employer to attend the conference. If you will not be receiving any financial aid, please include a confirmatory letter from your supervisor/employer with your application.
- Whether you are working on obtaining NAHO certification or recertification.
- Whether you have previously received a scholarship to attend a NAHO professional development conference and the year you received the scholarship.

Scholarship application letters must be received by July 7, 2023, to be considered. Only application letters providing all the required information will be considered. Recipient(s) will be announced July 21, 2023.

NAHO CERTIFICATION

The National Association of Hearing Officials is the only national professional organization for administrative hearing officials that offers a certification program for hearing officers and administrative law judges.

The NAHO certification program is dedicated to developing uniform standards of excellence and professionalism for hearing officers and administrative law judges across the country. Course requirements for certification ensure that individuals have a sound background in administrative law and hearing procedures. Certification stands as tangible evidence of your personal commitment to your own professional development and to a fair hearing process. NAHO membership is required for certification. Courses attended at this year's conference may be considered towards meeting certification requirements for 2023. Core requirements can be met by attending NAHO webinars, virtual and in-person NAHO conferences, viewing instructional videos of past webinars and conference classes via the NAHO Library, through courses completed at the National Judicial College, and by participating in other recognized programs addressing the administrative hearing process.

PAYMENT POLICY

Pre-payment for registration may be made only by purchase order, payment voucher, or credit card. Prompt payment is expected. NAHO will assess a \$75 monthly late charge per registrant on the first of every month for payments 60 days overdue from the date of billing and every 30 days thereafter. At the time of registration, NAHO must be informed of any information or materials that will be needed by an agency or state to process payment.
